Cale gave the Financial Report for May 2021. As of May 31, 2021, the Total Operating Fund is \$142,138.49. The Total Replacement Fund is \$1,208,540.66, for Total Assessments of \$1,350,679.15.

President Bowers informed all present the Accurate Voting would begin counting all votes for the Board of Directors election.

Election results were announced by Accurate Voting.

Bowers announced that the pools would be opening tomorrow-June 15<sup>th</sup>, with pre-covid rules in place.

The Bulky Item Pick up sponsored by Valley Vista Services will take place on Saturday, June 26<sup>th</sup>. A flyer will be delivered to all residents.

The completion of the roofing project will be postponed until the cost of materials drops. We are still experiencing a problem with shingles slipping off of some roofs.

Rental restrictions were discussed, and current percentages will be posted in the newsletter each month.

#### **NEW BUSINESS**

Bowers announced that the Board of Directors voted to begin foreclosure procedures on a vacant CTHOA property.

The Board of Directors received a bid for painting the wrought iron fences at the CTHOA pools, and it was approved.

The Board of Directors is considering changing the gate lock at the pool gates.

The plaque in front of the CTHOA office honoring former Manager Nancy Trainer will be replaced.

Bowers reported that the Cypress Police Department attempted to tow a car that had expired registration was towed and the owner was arrested for interfering.
